

Implementing the Asbestos Regulations

Louisa has worked in the electricity industry for 15 years. The majority of this time has been spent at the Huntly Power Station; starting off in 2003 as Quality Assurance Chemist and then as Team Manager for the Chemistry and Water Treatment team. In 2016 Louisa transitioned into the dark arts of Health and Safety and provides Health and Safety support across the Genesis Generation sites.

She was winner of the 2013 Safeguard award for "Most Influential Employee", and a finalist (with her Team and Hill Laboratories) for both the Safeguard and EEA Safety awards for the development of qPCR Fast turnaround Testing of Cooling Towers for Legionella.

Dan has over 15 years' experience in the electrical industry in the United Kingdom and New Zealand and is a trade-qualified electrician with supervisory, project management, regional management and engineering experience.

After joining Transpower in 2015, Dan was appointed Asbestos Management Advisor, and tasked with the transition of Transpower's operational project practices and policies from the previous asbestos regulations to the new Health and Safety at Work Asbestos Regulations 2016.

Dan and his team successfully integrated the new regulations, and initiated the National Asbestos Investigation which inspected all of Transpower's national assets. The output of this investigation helped to produce a National Asbestos Identification Programme, the national asbestos register, and educate and advise Transpower's employees and service providers of the asbestos risks.

Bobby joined the industry in 2010 as a Wind Technician during the construction of Te Uku Wind Farm. He comes from a wide range of large scale engineering/construction projects. For the past 4 years he has been working as a health and safety specialist for Meridians Corporate S&H team with wind being his customer.


He is here to talk about working at height, the risks involved and what Meridian are doing to mitigate these risks. Unfortunately, year after year workers are injured when objects are inadvertently dropped from heights, creating a significant threat for those on the ground. As we continue to refine the practices in our profession, the methods traditionally used for working aloft need to be examined and possibly modified. This will bring more control and safety to those on the ground who are near the overhead work being performed.

LV backfeeds

Stephen Albrecht is the Network HSEQ Manager at MainPower New Zealand Ltd. Stephen has 34 years' experience in the electricity supply industry in various roles, including HSEQ Advisor, Acting Grid Manager Operations, Safety and Training Manager, Compliance Manager, Operations Manager, Project Manager, and Senior Test Technician. Stephen is a Registered Engineering Associate (REA) and registered Electrical Inspector.

This session examines an incident involving an electric shock caused by low voltage backfeed. This presentation is intended to raise awareness of low voltage backfeeds by discussing this incident and the contributing factors. Sources of potential backfeeds, risk mitigation methods and the broader context of potential low voltage backfeeds when working on isolated network cables is also considered.

What's happening at WorkSafe

Tony is an experienced regulator. He has just joined WorkSafe as Head of High Hazards, Energy and Public Safety after 30 with years with GB's Health and Safety Executive. Tony's career began in pollution control and he joined HSE in 1986 as an inspector. He spent the first part of his career working on construction in and around central London and implementing the Construction Design and Management Regulations. He then had a range of roles including responsibility for regulating quality and continuity of the electricity transmission and distribution system before moving to lead HSE's Gas and Pipelines Unit covering offshore oil and gas pipelines bringing oil and gas from the North Sea onshore, the natural gas transmission and distribution network, LNG importation and other high hazard pipelines. He then moved to lead HSE's Energy Division covering all offshore oil and gas production, the onshore gas system, mining, fracking and diving.
